  - a. Seattle Police Department Justice Center, 610 5<sup>th</sup> Ave 1st Floor (\$7.00 fee for fingerprinting)
  - b. King County Court House Sheriff's Office, 516 3<sup>rd</sup> Ave - Room W-150 (\$11.00 fee for fingerprinting)
4. Entertainer only: must have a valid Seattle Business License Tax Certificate

**Full year license fee: Entertainer = \$170.00/Manager = \$216 / Half year license fee: Entertainer = \$85.00/Manager = \$108**  
**Background check fee: New applicant (fingerprinting) = \$58.00/Renewal applicant = \$11.00**
